Energy Saving: Gradually replace outdated and energy-consuming equipment with energy-efficient alternatives. Install LED bulbs and adopt sensor-based energy conservation measures. Avoid using electric lights in classrooms and halls where sufficient natural light is available.

Renewable Energy: Ensure energy security and conserve the nation's natural resources by installing solar power panels to augment the college's energy needs.

Waste Management: Ensure proper segregation of solid waste using color-coded bins across the campus. Implement sustainable solid waste management practices, including vermicomposting for organic waste.

Ban on Single-Use Plastic: Take proactive measures to ban single-use plastic and promote the use of jute or cloth products on campus to minimize plastic pollution.

Water Management: Implement rainwater harvesting systems, borewell recharge systems, trenches, ponds/bunds, and efficient water distribution systems to replenish groundwater and ensure judicious use of water resources.

Environmental Audits: Conduct regular energy audits, green audits, and environmental audits to assess and analyze the institution's environmental impact. Utilize the findings to implement energy-saving measures and improve the overall environmental condition on campus.
